How is this journeying together happening today in your local Church?

Celebration of the Mass, Communion, Reconciliation, Catholic education of our youth through the Catholic schools and Religious Education Classes, RCIA, Catechetical Classes, Marriage Classes, Bible study, Alpha, Eucharistic Adoration, Missions

What steps does the Spirit invite us to take in order to grow in our "journeying together"?

We need to go back to the roots of the Church and our Catholic identity by participating in the above. Everyone is welcome in our Church, and we need to make everyone aware of that. We need to identify those that feel left out and connect with them and reintroduce them to the beauty of our Catholic Tradition through Diocesan wide Missions and Pilgrimages. Talk to them, share a list of literature and programs that are available with them, offer to accompany them to programs or read the literature with them. The Diocese has many resources on their website, but not every generation is aware of them, and make them accessible to all. Promote the Catholic Faith utilizing all means of communication, i.e. television, social media, print. Etc.

What is the Holy Spirit saying to our Church today?

The Holy Spirit is the Love between the Father and the Son. The role of the Holy Spirit is to give hope and trust by sharing that Love with others. The Holy Spirit is the Breath and Life of the Church. He is asking us to pray daily for peace in the world. We are not the judges of other people and their ways. We should accept all individuals into our Church and community. We should lead by example and present a unified front to the World, which should start with our Bishops. We feel our Bishops are not presenting a unified front.

What should we do to improve our parish?

Invite and encourage greater participation in the Sacraments, Bible studies, Alpha, Rosary Society, Daughters of Isabella, Knights of Columbus, Catholic Book Club, Exposition and Benediction, Adoration, Evangelization, Marriage Encounters, Pastoral Council, Finance Council. Visit the homebound and sick. Participation in the community Thanksgiving dinner and food pantry. Vacation Bible School. Coffee and doughnuts after Mass. Pray and work together to improve our Parish. More interaction with the Diocese, more visits from the Bishop, guest speakers, Parish Missions and Pilgrimages, etc. We all have a role in our parish, everyone has different gifts. We need to encourage and invite everyone to utilize the gifts that God has given them through the participation in the events that are happening in our Parish. We also feel that we could keep our children more involved in the Church by changing the age at which they receive Confirmation.
