

#### National Eucharistic Congress – Indianapolis, IN

The Diocese of Gaylord along with the USCCB, has just announced the opportunity for 12 parishioners from our diocese to attend the National Eucharistic Congress in Indianapolis, IN. this coming summer July 17-21, 2024. Two parishioners from each of the six vicariates will be selected randomly on December 18, 2023.

The trip includes:

- One/individual, five-day pass to the Congress
- Four nights in a downtown hotel, double occupancy (food not included)

Charter bus transportation to and from Gaylord to Indianapolis If interested, this is what you need to do:

Submit your name, email, phone number, and parish affiliation to Deacon Scott at the parish office no later than December 3, 2023. Deacon Scott will then submit all interested applicant's names to the Director of Faith Formation for the Diocese of Gaylord, who will oversee the random drawing of names on December 18, 2023.

If your name is selected, Bishop Walsh asks that you be willing to give a witness talk about your experience, having attended the Congress, at a vicariate-wide event, which will include Eucharistic Adoration. Those dates are to be determined at a later date.

This is a great opportunity to, not only be able to spend time with your fellow Catholics from around the diocese, but an even greater opportunity to return and share with your fellow parishioners at St. Ignatius the amazing transformation that a Eucharistic Revival can bring to our parish.


