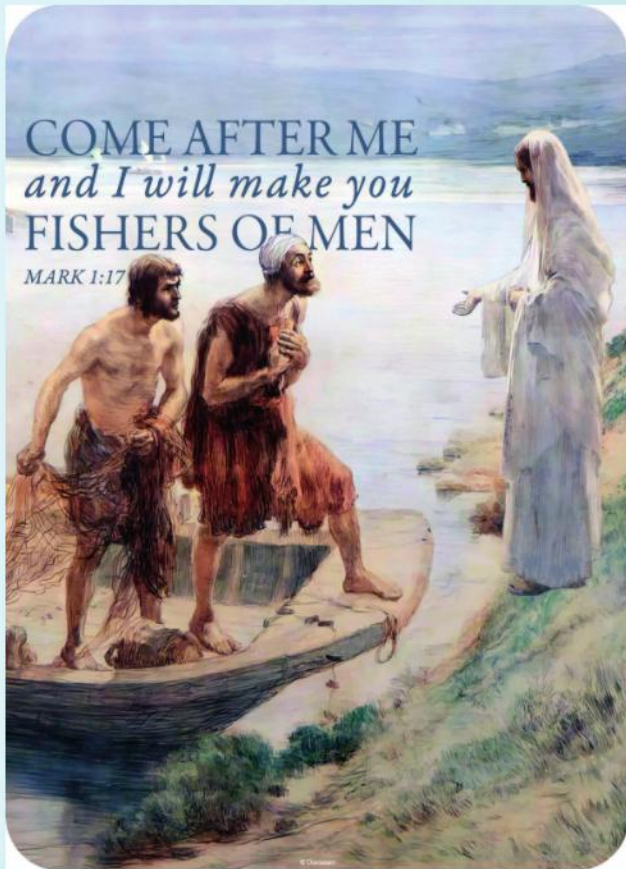

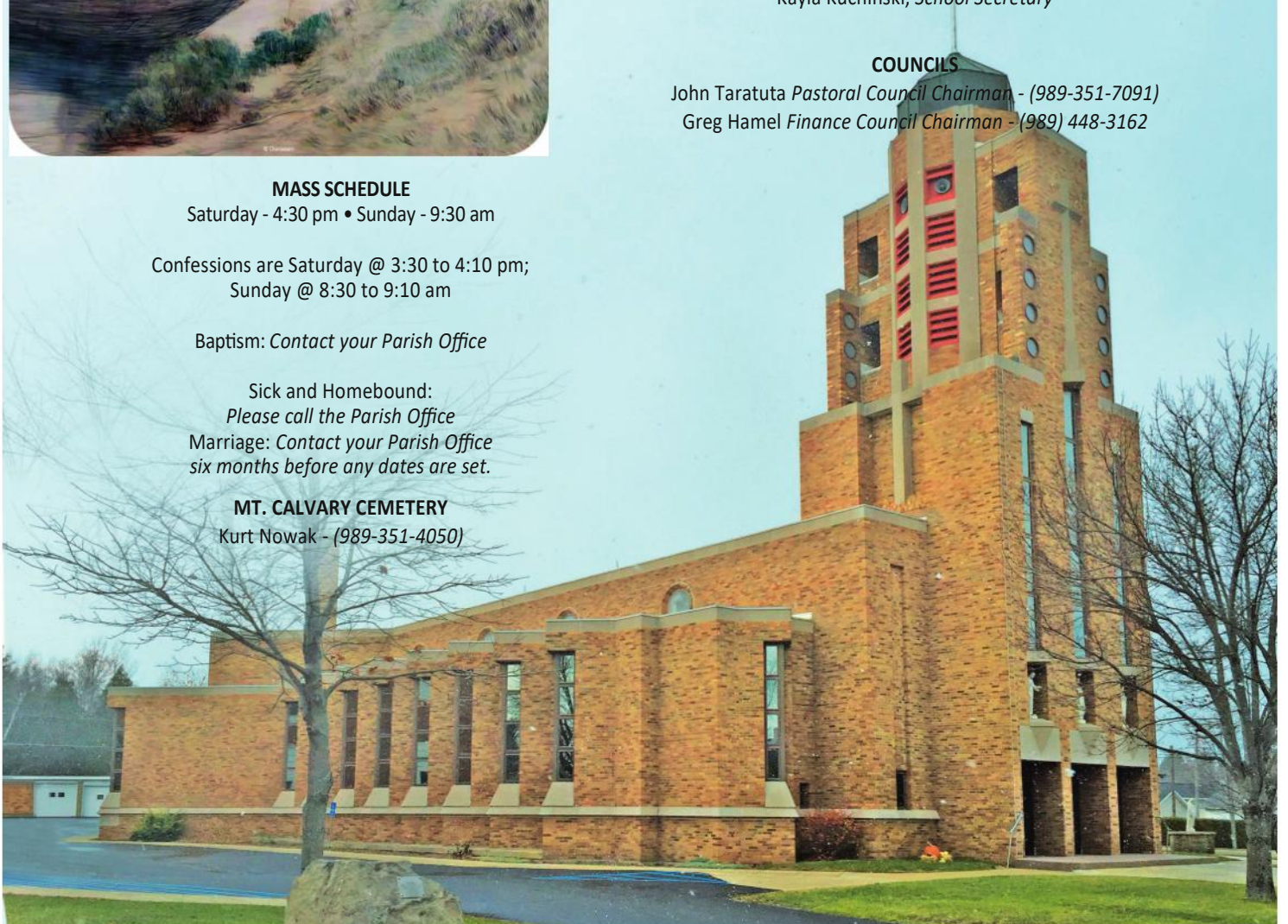

### **NEW MASS INTENTION POLICY beginning January 2024**

Due to the limited daily Masses being celebrated at St. Ignatius of Loyola Parish, there will be less opportunity for Mass intentions compared to in the past. According to canon law, if an offering for the intention is accepted, then that intention would be the only one for that Mass. We will try to make it as fair as possible using the following policies.

1. Two intentions per household per calendar year.
2. Of those two intentions, only one may be on a holy day or holiday.(e.g. Christmas, Easter, Mother's Day, Father's Day etc.).
3. There can be only one intention per Mass when an offering is given.
4. When a memorial/funeral offering for a Mass is given, regardless of the amount donated, we can schedule just one Mass for that offering.

### **A Call to Service**

This past weekend at Mass we heard from the 1<sup>st</sup> Book of Samuel, *"Here I am. You called me"* and from the Responsorial Psalm, *"Here am I, Lord; I come to do your will."* Both are meant to open our hearts to what God is calling each of us to do, to first serve Him and then to serve those in our community.

This past year, we had two of our parishioners resign their positions as members the Pastoral Council. Allow me at this time to thank both members for their loyal and dedicated service to serving the spiritual needs of this parish family, Kathy Talaske and Magnus Wilson.
