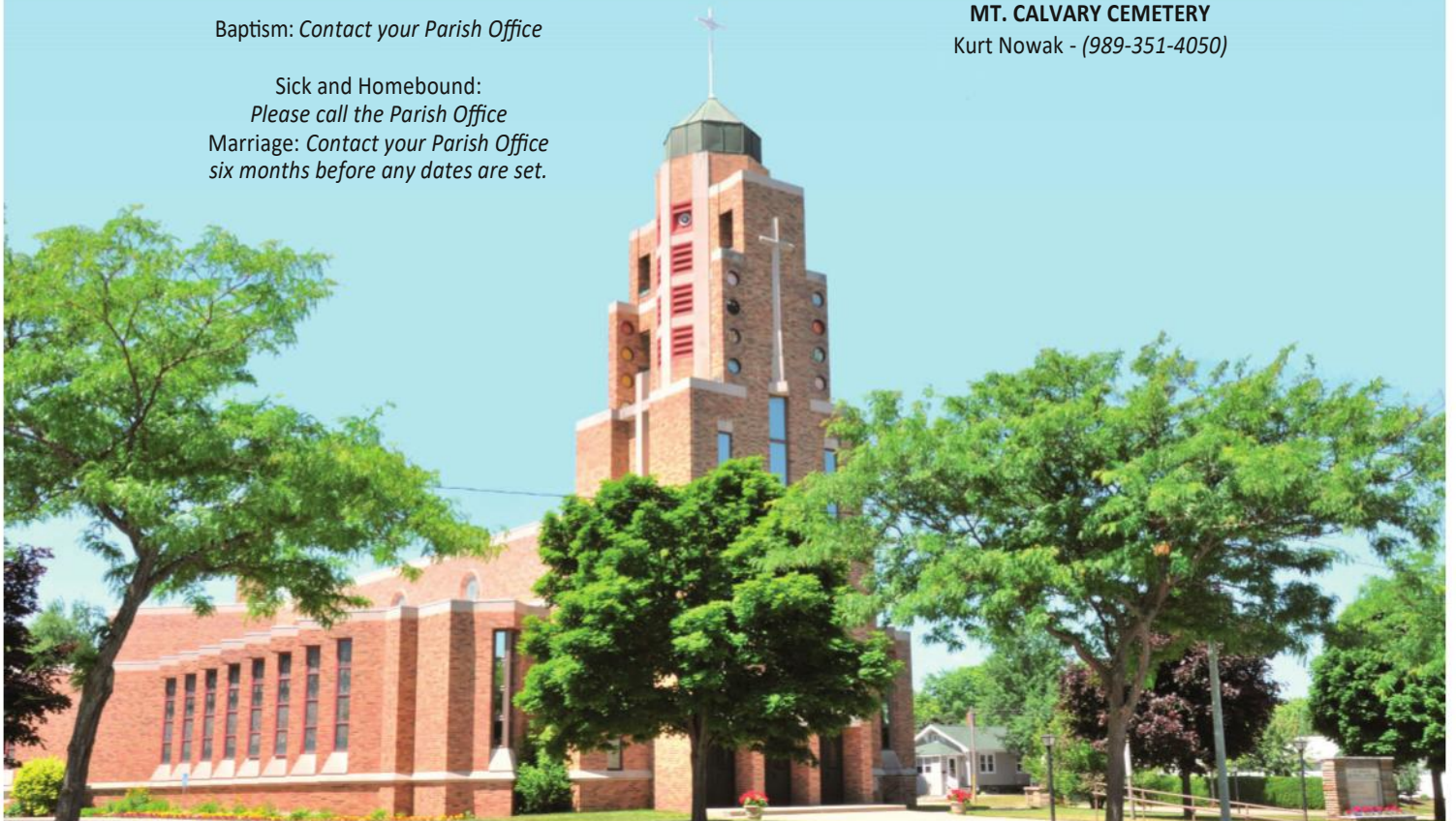

**YOUR GENEROSITY AT WORK...**

Perhaps you have noticed a change in the lighting and fans in our church. Recently all the church lights were retrofitted with LED bulbs, new can lights were installed on the altar and new fans were installed. The chandeliers that were taken down years ago to accommodate the center isle fans were cleaned and reinstalled in their original spots in the main aisle. New fans were then installed in the main aisle. The center aisle cove lights are functioning again with LED bulbs. The cost of the project was \$10,500 and was made possible in part by your generous donations to the improvement fund. The electrician estimates that we will have an 80% electrical energy savings for the church. In the upcoming months we will continue a maintenance report in the bulletins on projects that have been completed over the past few years. We are grateful for your support and are available to answer any questions you may have.
