





WEEKDAY MASS: Monday - Thursday @ 8:30 a.m.

The church is open for prayer throughout the week day from 7:30 am-3:00 pm.

The Diocese of Gaylord requires a three-year period of preparation for children receiving the sacraments of Reconciliation, Confirmation, and First Holy Communion. Children in grade one and their parents will begin separate sessions focused on Baptism. Children in the second grade together with their parents will prepare to receive Reconciliation. Children in the third grade will prepare for Confirmation and First Holy Communion along with their parents and sponsors.

Children who do not attend St. Ignatius School should begin faith formation classes in the first grade to lay a good foundation to receive the sacraments.

Faith Formation Classes

Registration for religious education classes is taking place now through September 7th.

Children in the first through fifth grade can register by filling out a form located in a blue folder at the church entrance and dropping it off at the Parish Office.

Sacramental Preparation Classes

Children in the first, second, and third grades together with their parents will be preparing to receive the Sacraments through a series of five meetings held throughout the year.

Registration will take place at the following meetings.

The first Sacramental meeting for parents only will be held in the school computer room on:

Grade 1 – Monday September 12th at 6:30 pm

Grade 2 – Monday September 19th at 6:30 pm

Grade 3 – Wednesday September 14th at 6:30 pm

These meetings are important with information about your child's preparation for the Sacraments.

One of the main principles of living a stewardship lifestyle is to give without expecting anything in return. This is difficult for some to comprehend in our "consumeristic" culture that we live in. This is even difficult for many parish communities that have become heavily dependent on parish fundraising events to support the mission and ministry of their local parish. Generally speaking, at a parish fundraiser, you pay money and receive something in return, It's just a financial transaction. This is opposed to our parish offertory at Holy Mass, where you unite your sacrifice with Jesus', renewing our covenant relationship with Him.
