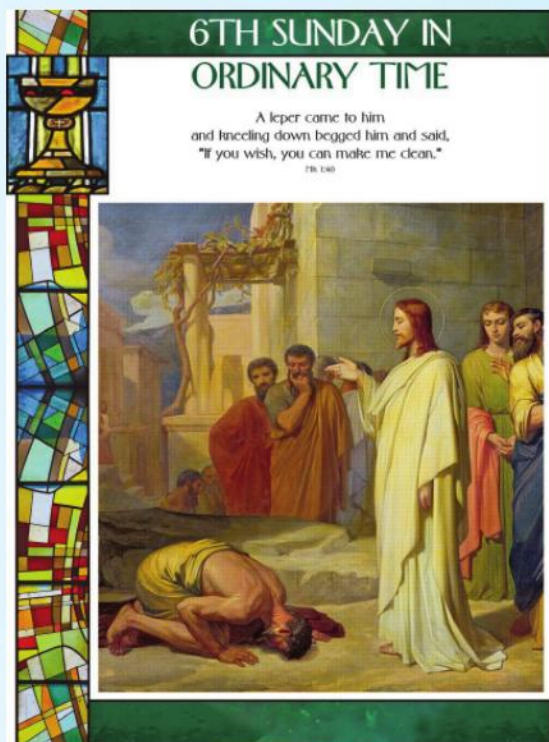

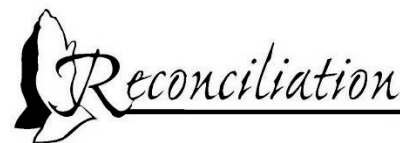


**From Bishop Hurley: A dispensation from the obligation to attend Mass on Sunday; and Holy Days of obligation for the people in the Diocese of Gaylord until further notice.** I do so that anyone who needs to stay home to protect the common good, themselves and others can do so in good conscience... **The granting of this dispensation is not meant to be a reason to absent oneself from Mass** (for other reasons). Conscience will always need to be our guide. If you are able to do so, I invite you to come back to the parish celebrations. Whether we are able to attend or not, we have a serious obligation to "Keep holy the Sabbath day." If you are not able to attend Mass, I ask that you set aside time for prayer, not only everyday but especially on Sunday.

**Attending a daily Mass will also satisfy the Sunday obligation.**
